# COMPLIANCE WITH STATEMENT OF BENEFITS SUMMARIES

#### PHILLIPS SAW & TOOL, INC

Investment in new equipment over the time period from April 2015 through January 1, 2020 has been \$840,434 for manufacturing equipment and \$7,858 for IT equipment. An additional \$131,182 has been invested in motor vehicles which were included in the logistical distribution equipment investment projection of \$150,000, but the motor vehicles were determined not to qualify for tax abatement. Therefore, through the end of 2019 Phillips Saw & Tool, Inc has invested \$840,434 in manufacturing equipment, which exceeds the minimum projected investment of \$750,000. The investment in IT of \$7,858 has been less than the anticipated \$60,000. The investment in motor vehicles as logistical distribution equipment has been \$131,182 of the projected \$150,000 expense. Employment has increased one full time and two part time employees and the payroll has increased by \$75,528 which is somewhat less than the projected minimum increase of four full time employees with a payroll of \$120,000.

#### CHYNOWETH REAL ESTATE HOLDINGS, LLC

Chynoweth Real Estate Holdings, LLC is the real estate holding company for Phillips Saw & Tool, Inc. Chynoweth Real Estate Holdings, LLC constructed a 50' x 100' new manufacturing building and installed a new sanitary sewer line. The projected cost was between \$250,000 and \$400,000 and the actual cost was \$324,360. All employment is through Phillips Saw & Tool, Inc.

#### BAILEY REAL ESTATE HOLDINGS, LLC

Bailey Real Estate Holdings, LLC has two projects, the 2012 – 30,000 square foot warehouse expansion and the 2015 -15,000 square foot expansion (the CF-1 form distributed has a typographical error describing the expansion as 1,500 square feet). These expansions are leased to NHK Seating of America and were made to facilitate its growing production for Subaru. The Bailey Trucking, Inc employment was projected to increase by four full time employees for the 2012 project and no employment increase was projected for the 2015 project. Current employment is twenty-five full time employees higher than in 2015 and forty-six full time employees higher from 2012. The number of part time employees has decreased from a high of fifteen in 2012 to the current number of three employees as of January 1, 2020. The payroll has grown from \$2,082,700 in 2012 to \$5,307,079 for the year 2019.

### NHK SEATING OF AMERICA, INC - 2017 PROJECT

The 2017 project at 2195 W. Barner Street is a 63,800 square foot warehouse for subassembly and cross docking of automotive seat components. The projected cost of the project was \$3,846,672 and the actual cost of the project was \$3,781.821. The 2017 project estimated an increase of 40 employees and an increase in wages of \$1,331,200. The employment has increased by 218 employees in Clinton County and the wages have increased \$11,089,795.
