Community Corrections Director Brett Barton stated there were 88 clients on electronic monitoring in July 2022 with 4 of those being juveniles and 8 on CTP. Grant was awarded with a 6.5% increase. At their last meeting, the Board approved the 2023 budget, a new K9 Policy, and a new Victim Notification Policy. The K-9 was recertified in narcotics detection and article search and received a new certification in tracking.

Central Dispatch

E911 Director Renee Crick invited the Council to come observe the annual LEPC exercise, September 1st, 9:00am at the Clinton County Fairgrounds. All local emergency agencies will be involved.

Board of Health

Rodney Wann, BOH supervisor, presented an accounting of the fiscal COVID grants that the department received from 2020-2022 for testing and vaccine clinics. This involves Funds 8112, 8113 and 8114. (Memo from Health Dept. attached).

Administrative reimbursements received from the State thus far total approximately \$360,000. Anticipate another \$40,000 before this program ends.

Sheriff

Sheriff Kelly informed the Council that their facility has been approved as an Indiana Workforce Development test site, with our own people doing the testing and teaching. Also, the department has held off on hiring positions through the Federal Inmate fund: 4 jail positions and merit road deputy

positions. Waiting on outcome of decision on Nepotism Policy and how that may affect Federal Inmate income.

Auditor

Auditor requested a motion to acknowledge Council's receipt of 2023 projections from the State, as previously referenced in the minutes. Upon motion by Council member Beard, seconded by Council member Chynoweth, said motion passed 6-0.
