### **Pictometry Contract**

The previous pictometry contract has expired, no cost incurred in 2021. A new contract is being worked on for the next 6 years, with flights scheduled every 3 years and resolutions of 3" and 6" being used. This information is used by the Assessor's Office, Area Plan and Surveyor's Office. The contracted cost will be \$27,340/year, which will be split between CEDIT, Reassessment Fund and Surveyor Fund. Council member Hensley motioned, seconded by Council member Chynoweth, to accept contract. Motion passed 6-0.

# **Commissioner Report**

Commissioner Brewer reported that the County will be receiving \$88,000 from City of Frankfort Utilities. These funds were generated through Tap Fees charged from the Water/Sewer project expansion to the new NHK facility.

He also stated that bids for the renovation of the 3<sup>rd</sup> floor of the Courthouse will be going out next month. Construction/renovation of the new grandstands at the Fairgrounds should be up for bid at the beginning of the year as well. An estimate of \$164,000 has been received for installation of new electrical lines underground. Council President Dunn stated that Council needs to reappropriate the funds for the grandstand project at the beginning of 2022.
