MINUTES OF THE CLINTON COUNTY COUNCIL MEETING JANUARY 14, 2025

The Clinton County Council met in the Commissioner's Meeting Room at the Clinton County Courthouse, Frankfort, Indiana on January 14, 2025, at the hour of 9:00 a.m. regular Council meeting, pursuant in accordance with law and publication as evidence by proof of the minutes of the last meeting, and any other business that may come before it. Auditor Britt Ostler led the Pledge of Allegiance and called the meeting to order. On call to order the following members were shown to be present or absent.

Britt Ostler, Clinton County Auditor, was present to record the proceedings of the Council.

Others present were Brett Todd, Renee Crick, Rick Campbell, Shawn Mayfield, Rich Kelly, Ashley Kelly, Liz Stitzel, Kevin Myers, Bert Weaver, Chris Overman, Dee Nicely, Amy Webster and others as mentioned in the minutes.

Mrs. Ostler asked for nominations for the position of Council President. Council member Hensley nominated Alan Dunn, seconded by Council member Chynoweth. Motion carried 5-0, Council member Dunn abstained.

President Alan Dunn then asked for nominations for Vice President. Council member King nominated Carol Price, seconded by Council member Hensley. Motion carried 5-0, Council member Price abstained

Council member Chynoweth moved, seconded by Council member Corrie, to approve the minutes of the December 10, 2024 meeting. Motion carried 6-0.

Council member Price moved, seconded by Council member King, to approve the minutes of the December 26, 2024, meeting. Motion carried 4-0, Council members Dunn and Corrie abstained.

COMMUNITY CORRECTIONS

Brett Barton was not in attendance but the department's 2024 Annual Report had been submitted in the Council packets for their review.

PROBATION

Chief Probation Officer, Nancy Ward, was not present but her report had been provided to the Council for their review. Juvenile detention costs for the month of December were \$0; \$10,115.00 for the year 2024.

NEW BUSINESS

An Ordinance of the Clinton County Council of the state of Indiana for the Payment of Recorder's Office Expenses and Salaries from Recorder's Perpetuation Fund - Ordinance 2025-01

This is required by the State and will formalize the process the County has been using with the Recorder. Motion by Council member Chynoweth, second by Council member Hensley, to adopt Ordinance 2025-01. Motion passed 6-0.

2025 Salary & Wage Ordinance 2025-02

Upon motion of Council member Price, seconded by Council member Chynoweth, the Motion to Approve the 2025 Salary & Wage Ordinance was approved 6-0.

Central Dispatch - Change in Existing Position/ 2024 Annual Report Renee Crick, Director

Renee Crick presented the 2024 annual report to the Council. (See Attached) Some highlights were as follows: filling Assistant Director position, remodeling of Central Dispatch, new training program implemented by the Assistant Director, received a \$86,798 grant to purchase portable radios and laptaps for remote communication in emergency situations, and purchased Training Tracker program which has been very beneficial. They need to hire 3 more dispatchers to be fully staffed.

The Statewide 911 2025 budget had a Shift Supervisor/Training Coordinator position. After reassessing everyone's duties, it was realized that the Training Coordinator duties have now been taken on by the Director and Assistant Director. Requesting to change that line to just a Shift Supervisor. That would give the department a total of four supervisor positions. The Council has no objection.

Highway Department – Change in Positions – Rick Campbell, Superintendent Mr. Campbell recommended changing two truck driver positions be changed to operators due to an increased need for those duties. The Council has no objection.

Financial Reports

Motion made by Council member Chynoweth, seconded by Council member Hensley, to approve review of the December 2024 financial reports. Motion carried 6-0.

COUNCIL REPORTS

Carol Price attended the First Ladies breakfast for the new governor. There has been a delay in finalizing Jane Pauley Center as our mental health provider. 2 other mental health providers have come forward to contest the Jane Pauley Center and request an opportunity to be our mental health provider. Commissioner Weaver had contact with one of those providers and expressed the County's opinion regarding their company and to discourage them from proceeding.

Community Corrections had looked at the prospect of remodeling the old Police Station. The estimated cost of remodeling has come back more expensive than anticipated, making that option unfeasible.

President Dunn spoke regarding plans for the City of Frankfort to be responsible for 50% of the PIP budget beginning in 2025. An Interlocal Agreement is in the works to make this happen.

COMMISSIONER REPORTS

None.

DEPARTMENT REPORTS

EMS – Director, Steven Deckard, reported they are through the first EMS training class and 1 of the students signed contract to begin their employment with Clinton County.

Director Deckard also reported that the Council approval of ISTATS equipment last year proved beneficial in a recent case. He thanked the Council for allowing this purchase.

Total transfer revenue for 2024 was \$1,516,000, an increase of \$280,000.

Full time paramedic will join EMS in April. He would like to complete the ride along training before that time. Council was agreeable to transferring funds from full time paramedic line item to part time.

SHERIFF

Rich Kelly spoke regarding their immediate need to replace a minivan, may reach out to Community Corrections to see if they'd be willing to assist in funding through their Misdemeanant Fund. Current maintenance issues at the jail with duct work rotting out; major electrical problems will be an expensive project.

Matron Ashley Kelly submitted the semi-annual Commissary report for July 1, 2024 – December 31, 2024 to President Dunn. Reported that through re-billing inmate medical bills. produced a 95% savings in medical expenses.

Matron Kelly reported that for 2024 there were 36 graduates from the MRT program, with 100% success rate (0 recidivism). Also, the 5th class of JCAP participants graduated 7 men. There were 9 adult education graduates. The new Federal inmate contract has been signed for a per diem rate of \$90, with \$35 transport fee reimbursement, beginning February 1, 2025.

Sheriff Kelly spoke regarding the Commissary contract needs to be finished up. Highly suggests a new jail needs to be built.
