MINUTES FOR THE CLINTON COUNTY COUNCIL MEETING March 14, 2023

The Clinton County Council met in the Commissioner's Meeting Room at the Clinton County Courthouse, Frankfort, Indiana on March 14, 2023, at the hour of 9:00 a.m. regular Council meeting, pursuant in accordance with law and publication as evidence by proof of the minutes of the last meeting, and any other business that may come before it. Council President Alan Dunn called the meeting to order and led the Pledge of Allegiance. On call to order the following members were shown to be present or absent.

PROBATION

President Dunn read the February 2023 report of Chief Probation Officer Nancy Ward which noted Juvenile detention costs in the amount of \$0.00 for the month.

NEW BUSINESS

NHK CF-1's – Attorney Phil Triplett presented the 23 pay 24 CF-1's for NHK and Bailey Real Estate Holdings, LLC to the Council. Employee numbers for NHK show some temporary workers that will likely be filled with full time employees. NHK representative, Amy Decker, spoke regarding how hard retaining employees has been.

New Communications Consultant - Commissioner President Jordan Brewer introduced Tammy Sander as the County's new Communication's Consultant. Ms. Sanders works for Mother of Pearls consulting firm. She will be meeting with department heads to find out their needs.

2023 Salary Ordinance 2023-05 (Readopting with Changes)

A revised Salary Ordinance was presented for approval upon motion by Council member Chynoweth, seconded by Council member Mink. Motion carried 7-0.

Parkview Home Boiler Quotes - Director Chris Overman presented 3 quotes for a more efficient boiler to be installed. Fluid Technologies, LLC, presented the lowest quote at \$89,900.00 and this is who Mr. Overman recommends going with. Council is fine with this quote, but asked that he hold off for a month or 2 so that a funding source may be figured out.

School Resource Officers Financial Proposal – Sheriff Rich Kelly presented an updated report on the hiring/funding of two school resource officers (See attached report). Sheriff Kelly is asking for a total County contribution of \$84,911.02 for the 2 officers which would pay for the fringe benefits. Clinton Prairie and Clinton Central are responsible for the salaries. There will be two additional officers hired for these Merit Deputy positions. These deputies would be available when school isn't in session. There are currently existing officers who are interested in applying. A Memorandum of Understanding is to be signed between all parties involved. President Dunn and Commissioner President Brewer expressed their desire to be included in the review and signing of said document. All members are in favor of proceeding and believe this is very important. Council member Price presented a motion to move forward, contingent on agreement of terms in MOU, seconded by Council member Beard. Motion carried 7-0.

Request for New Board of Health Positions – Rodney Wann spoke regarding hiring a full time Immunization Nurse and full time Health Administrator. A detailed proposal was presented and is attached. Mr. Wann would like to start the nurse position immediately. Upon motion by Council member Hensley, seconded by Council member Chynoweth, the creation of said positions was approved 7-0.
