The Clinton County Council met in the Commissioner's Meeting Room at the Clinton County Courthouse, Frankfort, Indiana on November 9, 2021, at the hour of 9:00 a.m. regular Council meeting, pursuant in accordance with law and publication as evidence by proof of the minutes of the last meeting, and any other business that may come before it. Financial Reports

Motion made by Council member Beard, seconded by Council member Hensley, to accept the October 2021 financial report. Motion carried 6-0.

Council Reports

President Dunn stated that the Council had in their packets a letter from the Auditor's Office stating two loans from Hospital Contractual have been repaid: \$50,000.00 from COVID Testing Grant II (8113) Fund and \$50,000.00 from Board of Health (1159) Fund.

Council member Chynoweth stated that the Council had received an email from Coroner Ed Cripe informing the Council that the new morgue is operational and inviting them to come tour the facility.

Commissioner Reports

Department Reports

Central Dispatch director, Renee Crick, reported that they had received an extra distribution from the State 911 fund. She is helping with Learning to Lead and has organized a demonstration for the attendees by the Frankfort Fire Department at the new EMA training facility.

Mrs. Crick also inquired about the status of the ARPA monies and if any decision had been made about giving County employees who worked during COVID "shutdown" a bonus from said funds. President Dunn stated that a decision has not yet been made as to how to spend any of that distribution. Some of those funds may be needed to make a bond payment that's due in January 2022.

Jami Pratt, Center Township Trustee, gave the Council an update on the newly opened Homeless Shelter "Home for the Night". She detailed the data base they are using to keep track of individuals who are applying and their information. This will enable them to know what townships they are coming from and to effectively use taxpayer dollars to help those who truly desire the assistance. There have been 6 applicants thus far. Mrs. Pratt is asking for assistance in funding the salaries of the shelter employees for the remainder of 2021. The City has already given \$22,000.

Anita Stewart from United Way spoke as did Lorra Archibald, Healthy Communities Director, regarding the wrap-around services available to those staying at the shelter. Any individuals seeking shelter are required to follow-through with these services.

Commissioner Dunn, and the Council, commended all the agencies involved with the new shelter for implementing an effective process to assist those who are legitimately seeking shelter and assistance in bettering their life circumstances.

Motion made by Council member Chynoweth, seconded by Council member Gascho, to provide a one-time donation of \$22,000 from Landfill Fund to the shelter. Motion carried 6-0.

Rodney Wann, Board of Health Administrator, spoke regarding the reimbursements the BOH has received from the State Board of Health for administrative costs during the pandemic. Those reimbursements had been billed to and paid out by Medicare and other private insurances. The State has been serving as a third party billing service to send out invoices for these administrative fees. The intent of these monies is to build an infrastructure for preparing for future health emergencies. \$220,000 should be coming in the next month or so from the schools.
