Central Dispatch

Central Dispatch Director, Renee Crick spoke regarding the LEPC and said they had a great turnout for tabletop. Approval from the State is still being waited on. A meeting at Clinton Prairie was held afterward to go over things that need implemented or went well. Sheriff, EMS, all together and presented a unified command if an emergency arose. They had a total of 70 responders.

Council member Gascho reported that Auditor Britt Ostler received an Institute for Excellence Certificate at the AIC Conference held in French Lick..

Shan Sheridan reported that Channel 18 did a story on the I65 project. A local homeowner had contacted them to discuss their concerns. He stressed that Government leaders need to be on the same page with this project so we present a united front. Council member Beard stated that the APC has given favorable reports to the Commissioners on 2 sites for change in zoning.

Sheriff

Sheriff Rich Kelly reported there are currently 175 inmates; thought there would be more. Possibly affected by pretrial release.

Upgrades still need to be made to HVAC.

The Department is attempting to raise money for another K-9 Officer.

Still planning to hold an auction of surplus items, will go through site Dan Sheets runs.

Federal prisoners, they require us to take 50 but that will make us at our maximum. Sheriff Kelly is still in negotiations to see if they'd allow us 20 prisoners instead of 50.

Sheriff's Office has a Merit position open and applicants have been plentiful.
