# MINUTES FOR THE CLINTON COUNTY COUNCIL MEETING November 12, 2024

The Clinton County Council met in the Commissioner's Meeting Room at the Clinton County Courthouse, Frankfort, Indiana on November 12, 2024, at the hour of 9:00 a.m. regular Council meeting, pursuant in accordance with law and publication as evidence by proof of the minutes of the last meeting, and any other business that may come before it. President Alan Dunn led the Pledge of Allegiance and called the meeting to order. On call to order the following members were shown to be present or absent.

Council President Alan Dunn opened the meeting with the Pledge of Allegiance.

Upon motion of Council member Chynoweth, seconded by Council member Mink, the Minutes of the October 8, 2024, Council meeting were approved 5-0.

#### **COMMUNITY CORRECTIONS**

Community Corrections Director Brett Barton stated there were 80 clients on electronic monitoring in October 2024 with 1 of those being juveniles and 1 on CTP. 1 person is currently on Pre-Trial Release. The new drug testing vendor is up and going and they're very pleased with them; very professional. Still looking into the viability of renovating the old police station into a new location for Community Corrections. Waiting on a report from Envoy.

### **PROBATION**

The Council reviewed the Probation Report submitted by Director Nancy Ward. Juvenile detention costs for the month of October 2024, were \$1350.00.

#### **NEW BUSINESS**

**Healthy Communities of Clinton County, Lorra Archibald** – Mrs. Archibald reported on the Fall distribution requests and that were those approved by the Opioid Settlement Committee. There were 8 requests; 7 were recommended for full or partial funding. In total, the City would receive \$5101.50 and the County \$31,830.50. The Committee recommendations were as follows:
