Commissioner Woods reported our health insurance experience is going well. 75% of our employees have participated in the biometrics screening for wellness and prevention. ### Department reports

Sheriff Rich Kelly - We have been approved for a \$80,000 grant to replace a trailer operation center. Trailer is for SWAT; trainings; fair, etc. The Sheriff also announced that Rick Morgan is resigning later in the month.

Health Department - Rodney Wann spoke regarding hiring a new health nurse, Dana Longnecker. Cash on hand indicates the Health Dept. will not need a loan. The mobile food pantries will once again allow the health dept to help with the food pantry.
