# MINUTES FOR THE CLINTON COUNTY COUNCIL MEETING September 14, 2021

The Clinton County Council met in the Commissioner's Meeting Room at the Clinton County Courthouse, Frankfort, Indiana on September 14, 2021, at the hour of 9:00 a.m. regular Council meeting, pursuant in accordance with law and publication as evidence by proof of the minutes of the last meeting, and any other business that may come before it. **CIRCUIT COURT** – Judge Mohler spoke regarding pauper fees. To date, \$372,000 has been reimbursed, reduced budget since participating in this program.

**PROSECUTOR-** Superior Court will see the fees from the new murder trial going on currently. Some costs will be covered by the State. Average cost for a Capital case is \$750,000. The expenses will vary in cost and Tony feels it's entirely too early to tell which way the case will go. It will take additional manpower to try this case, so extra personnel would be imperative at this time.

#### **COMMUNITY CORRECTIONS**

Community Corrections Director Brett Barton stated there were 94 clients on electronic monitoring in August 2021 with 10 of those being juveniles and 3 on CTP. 11 individuals currently on Pre-Trial Release. Their grant was renewed for 2022 with a 28% increase.

ARPA Funds – Renee Crick spoke regarding bonus for County employees using the ARPA monies. Lora Wellman, Tim Dillingham and Rich Kelly spoke in support of the bonus. President Dunn completed them on their presentation and said that he would anticipate the Council making a decision on this matter by the end of the year.
